

NOTES

- Fascia includes splice plate at joints
- Standard fascia will not function with TPO or PVC strip-in membrane thicker than .060"
- Oil canning can occur on larger face heights; recommend .050"" or .063"" for face heights above 8.25"
- Welded accessories require minimum material thickness of .050"
- Unless otherwise noted, fabrication of miters and accessories are furnished standard
- For non-90 miters, see separate print approval
- Product should be installed per provided installation instructions
